The Civil Legal Aid (Remuneration) Regulations 2013

From 1 April 2013, all legal aid providers will be subject to new or amended contracts. Face-to-face provision for family, immigration and asylum, housing and debt will be governed by the 2013 standard civil contract. Providers of civil legal aid in categories that have not been re-tendered and crime practitioners will be subject to the amended 2010 civil and crime contracts. Useful links:

Provides a standard form of general conditions of contract for incorporation into construction contract documents. This standard is similar to NZS 3910:2013, but has been adapted to provide for the situation where the Contractor is responsible for design as well as construction.

Conditions of contract for building and civil engineering

All existing standard civil contracts (except Mediation) that are due to end before 31 March 2018 will be extended through to this date. To enable this alignment it is also our intention to end any contract that runs past 31 March 2018 early (ie actions against the police etc, clinical negligence and public law).
